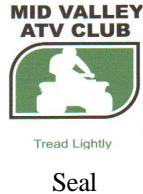

**Mid Valley ATV Club Code of Ethics**

1. I will be a good sportsman. I realize people judge all ATV's by my actions. I will use my influence with other ATV's to promote sportsmanlike conduct.
2. I will not litter on any trails, camping areas or private property nor will I pollute any streams, brooks, rivers, dead waters, swamps, ponds, lakes or any other natural habitat. I will carry out what I carried in.
3. I will not damage any trees, shrubs or any other natural features.
4. I will respect other people's property and rights.
5. I will lend a helping hand when I see someone else in distress.
6. I will make myself and my ATV available to assist in any search and rescue operation.
7. I will respect the rights of any winter sportsman.
8. I will obey all federal, provincial and local rules regulating the use of ATV's on the trails.
9. I will not harass wildlife.
10. I will not ride where prohibited by law or private landowners.
11. I understand "it is an offence under the criminal code to ride an ATV while impaired by **DRUGS or ALCOHOL**:
12. Membership can be CANCELLED after: **1<sup>st</sup> offence** – a verbal warning, **2<sup>nd</sup> offence** – a written warning, **3<sup>rd</sup> offence** – expulsion (depending on the severity of your actions).
